LIFTT ESTABLISHES NEW EMERGENCY FUND

**LIFTT is pleased to announce a \$30,000 grant from the
ORO Y PLATA FOUNDATION
to create the "Jackie Kimbrough Emergency Fund,"
to assist LIFTT consumers in financial distress.**

Named in honor of Jackie Kimbrough, a former employee of the agency who passed in 2021, LIFTT plans to use the Emergency Fund to help people with disabilities meet unanticipated expenses. To qualify for assistance, consumers cannot receive assistance from any other available federal and state program funding. The expenses that can be paid for with funds from the emergency fund vary from significant home repairs to replacing appliances.



LIFTT is a Montana 501(c)(3) Corporation organized as a (CIL) Center for Independent Living. As part of a nationwide network of CILs, LIFTT provides people with disabilities with Independent Living (IL) services in the area formed by the eighteen counties: Big Horn, Carbon, Carter, Custer, Dawson, Fallon, Garfield, Golden Valley, McCone, Musselshell, Prairie, Powder River, Richland, Rosebud, Stillwater, Treasure, Wibaux, and Yellowstone.

According to Carlos Ramalho, LIFTT's Executive Director, the creation of this fund is, "an effort to help our consumers – persons with disabilities – stay in their homes, live independently, be able to participate in their communities, and avoid institutionalization."

"LIFTT would like to thank the Oro y Plata Foundation for this generous grant to get the fund started; we hope many others will help make it grow over time by their contributions," Ramalho said.

STAFF PROFILE: Nancy Grigsby



How anyone ends up anywhere is an indefinite patchwork of dispositions and happenstance, along the current of life. “Well I don’t even know where to begin,” said Nancy Grigsby.

Glendive has been a common thread throughout Grigsby’s life, along with providing care for those who seem to need it most. After moving away to Beach, ND., to be near a mother who needed assistance, she returned to Glendive in 2007.

She’s worked in different group homes for Autistic Children and Bipolar and Schizophrenic adults, a testament to anyone’s reservoirs of empathy and patience. Nancy found out about LIFTT and their mission through a friend and began in April as an IL (Independent Living) Specialist.

“I love this job, I wish people knew more about it,” she said. “It’s such a good resource and people have a hard time asking for help. We’re down to earth and not judgmental. It’s like a family, just helping you along the way.”

She appreciates the outreach of LIFTT and seeing people fully grasp the calling of the program, preserving dignity for those with disabilities and ensuring a life of unencumbered independence.

“Telling people ‘hey this is what we do’, there is this ‘ah-ha’ moment and then they realize what we do is pretty special,” she said.

Nancy has the exciting opportunity to work with the EMT/ LIFTT PCA Program to provide increased care assistance for those living with disabilities in Eastern Montana. The program helps subsidize the family members providing for those with disabilities living in their homes. Caring for family members with a disability is a full-time job.

“To keep people living independently at home is really important,” she said. “How does (the care provider) financially survive if they’re not getting paid?”

Many of the people who need this assistance, physically or financially, can’t qualify for Medicaid. The AEMT/LIFTT program seeks to aid those left on the margins. The program has shed light on the nuance of these bureaucratic nightmares, and the realities of these distinctly rural concerns. How do you gauge who is deserving of assistance and who isn’t?

“Say they inherited a farm, and that’s all they have to their name, but that’s too many assets to qualify (for Medicaid)” she said. “This program takes over where that leaves off.”

As an IL Specialist Nancy works one-on-one with consumers to help them stay living as independently as possible. “We help them along the way,” she said. “It’s exciting just to be able to help people. I love that.”

How to strengthen the partnership between CILs and Pre-ETS

Growing up does not have to be a scary thing for anyone! No matter our age, we are all experiencing growth and change.

Youth with disabilities, however, need to remember that there are amazing things about growing up! There is no need to be intimidated by the future because it always holds good stuff for those willing to live life to the fullest. As a Center for Independent Living (CIL), LIFTT is an advocate for change in the lives of individuals, public and private institutions, and corporations.

As LIFTT's Executive Director, I want to find innovative ways to provide independent living services to the younger generation of citizens of Southeastern Montana living and studying with a disability. These innovations will continue to strengthen the existing partnership between LIFTT and the Pre-ETS.

The term Pre-ETS is an acronym that stands for Pre Employment and Transition Services. Pre-ETS is part of the Montana Vocational Rehabilitation and Blind Services division of the Montana Department of Public Health and Human Services. It supports programs that help disabled young adults still attending high school prepare to transition into higher education, careers, and life.

To transition means growing up and becoming an independent, responsible, and productive

citizen. Given the opportunity, youth with disabilities are willing to face the challenges of having different life experiences. When provided with the necessary ADA accommodations, they succeed.

It makes perfect sense for LIFTT to work hand in hand with Pre-ETS because 'youth transitions' is one of our six (6) core services. It is LIFTT's mission to open doors to the disabled youth and fill their toolboxes with skills they can use as adults regardless of their path for their future, be it work or higher education.

LIFTT wants to encourage and motivate disabled students by promoting conferences and workshops, training, counseling, college application coaching, resume writing coaching, and providing them with a safe space to relate to their peers. We will also help them find a work site or educational institution that is willing to allow them to gain work experience or study while being supported as part of their transition process.

We invite you to join us in this new adventure in leading our disabled youth on the path of freedom, maturity, respectability, discovery, learning, and success!
