TRACKING SUCCESS: Jeremiah Thompson



18-year-old Jeremiah Thompson was afloat. He was a high school dropout with no job, no future on the horizon and no place to go. "I didn't know what to do" he said, "and I really needed help!" Jeremiah's sister reached out to Independent Living Specialist Jen Hawkinson from the Glendive branch of LIFTT, hoping she could get Jeremiah back on track. Little did Jeremiah know that Hawkinson was a powerhouse of ideas and a relentless advocate. "Jen is super persistent," said Jeremiah, "she was on me 24/7, no slacking'."

Jen met with Jeremiah and his family to discuss options that would help him obtain his

school diploma which included enrolling in the High School Equivalency Test (HISET) offered by both the Dawson Community college in Glendive, and the Job Corp program in Anaconda.

Jeremiah was drawn to Job Corp because it included occupational training courses and the High School Equivalency Test. Jen obtained the application papers from a Job Corp recruiter, and helped Jeremiah fill them out. Unfortunately, there was a snag. Jeremiah was missing essential documents including his birth certificate, social security card and school transcripts. He had no idea where they were, and neither did his family, but that didn't stop Jen. Undaunted, she told him to contact Action for Eastern Montana, a nonprofit organization committed to promoting education. Jeremiah had been enrolled at Action as a child and was able to retrieve the necessary government forms. She assisted him in getting a replacement for a lost Social Security card. Jen then invoked the Freedom of Information Act (FOIA) which provides public access to all federal agency records, allowing Jeremiah to take possession of his elementary and high school transcripts.

Once everything was in place, he submitted the Job Corp application and, shortly afterward, was accepted into the program. Despite the successful outcome, Jen wasn't finished yet. She had recognized that Jeremiah's disorganization was a barrier to his future and, through guidance and providing him with a personal lock box, Jeremiah can now locate his important documents. "It is discouraging to keep losing things and be so disorganized." he said, "but thanks to LIFTT and Jen, now I know where everything is!"

Today, Jeremiah's future is bright. He owns a car and recently landed a maintenance job. He is considering returning to Job Corp at some point, but right now, Jeremiah is attending high school in Dickinson, North Dakota, working for his dad and keeping his life on track.

DIRECTOR'S CORNER

On July 6, 2021, LIFTT was re-opened to the public. We were happy, hopeful, and optimistic that the pandemic would recede and did not want to believe that mutations of the Coronavirus would bring it back. Unfortunately, that's what happened. A highly contagious SARS-CoV-2 virus strain called Delta variant of COVID-19 spread rapidly through the United States and became a threat. According to the CDC, the Delta COVID-19 is much more transmissible than the common cold, influenza, smallpox, MERS, SARS, and Ebola and is as contagious as chickenpox.

On August 1, 2021, we were alarmed because the Delta COVID-19 was quickly spreading in places with low vaccination rates like Montana. On August 16, 2021, authorities confirmed that the Delta variant of COVID-19 affected even vaccinated citizens whose immune systems are compromised. Yellowstone County reported 703 new cases compared to the 451 new cases reported during July. Given the seriousness of the situation, to protect consumers, team members, and our community, once again, until further notice, LIFTT decided to close its doors to the public. However, LIFTT will continue to provide services to everyone via telephone and the internet. In special situations, LIFTT team members even agree to meet consumers in person, by appointment only, provided they are not experiencing any symptoms of COVID-19, flu and have not been in contact with anyone sick with COVID-19.

LIFTT is always open and available to provide consumers with services even though its doors are closed. We encourage you to give us a phone call, send us an email, connect with us on Facebook and Twitter. Clicking with one of our Independent Living Specialists will most certainly open up a world of possibilities and opportunities for you.

We are always available to meet you online via Skype or Zoom. Please do not let the Delta variant of COVID-19 stop you.




Protect yourself from the Coronavirus Delta Variant LIFTT wants to keep you safe!
